

Faculty Position in Petroleum Engineering Missouri University of Science and Technology Rolla, Missouri

The Department of Geosciences and Geological and Petroleum Engineering at the Missouri University of Science and Technology (Missouri S&T) in Rolla, Missouri is seeking outstanding applicants for a non-tenure track faculty position in the areas of drilling, drilling safety and drilling automation. Preference will be given to applicants who can contribute to the department's areas of strength such as experience working in the petroleum industry. Competitive salary commensurate with the rank and qualifications of the candidates will be offered.

Successful candidates will be expected to have strong commitments to (a) high-quality teaching both at the undergraduate and graduate levels in courses such as drilling and well design, offshore petroleum technology, drilling automation, unconventional petroleum resources, directional drilling, and petroleum reservoirs. (b) service in the applicant's professional community and our institution, and (c) increasing the diversity of both the student body and faculty. Applicants should have evidence of potential for excellence in high-quality teaching, service, and increasing diversity. Additionally, senior candidates should have demonstrated excellence in high-quality teaching. Applicants must hold a Ph.D. in Petroleum Engineering or a closely related field. Experience in the petroleum industry and eligibility for professional engineering registration are considered assets.

The GGPE Department has 22 tenured/tenure-track faculty and approximately 600 students (roughly evenly split between graduate and undergraduates). All of our programs offer B.S., M.S. and Ph.D. degrees. The Petroleum Engineering program is ABET accredited and has 6 tenured/tenure-track faculty, approximately 140 undergraduate students and 63 on-campus graduate student.
